

WHY ARE FAMILY BUSINESSES DIFFERENT?

There are three key ways in which family businesses stand out with regard to the level of cohesion they are able to achieve:

- A shared history, with family stories and memories becoming company 'folklore'
- An ability to maintain the family culture that makes the business unique, while also operating in the modern, ever-changing world
- A desire, and even a requirement, for honesty and authenticity across all generations and around the world

- Access to information vs. overwhelm and disorganization

EXPLORING COHESION: THE "AIMING FOR YES" QUESTIONS

Some questions to ask when considering how cohesion is being achieved in your family business:

 Do you feel all generations of the family are represented in decision making?

 Can you easily locate and access the latest version of every document?

- Do the learnings of previous generations inform later generations?
- Is a culture of learning embraced and learning opportunities supported?
- Are you kept informed on all upcoming meetings and collective commitments?
- Do you actively seek to prepare, together, for the future?



EXPLORING COHESION: THE "AIMING FOR NO" QUESTIONS

Some questions to ask when considering how cohesion is **not** being achieved in your family business:

- Is communication throughout the business overly complicated?
- Do complex security requirements alienate some family generations?
- Do you repeat previous mistakes on a regular basis?
- Is it difficult to find archived documents and other materials from the past?
- Do you lose track of your current actions and those of others?
- Are family members from throughout the world sometimes excluded from business activities?

FOUNDATIONS FOR COHESION

What is needed to provide for cohesion in today's family business?
